A non-refundable booking fee of \$100.00 is required with this signed breeding contract. This fee shall be applied against the stallion service fee of \$500.00, for said stallion, which mare owner agrees to pay in full at the time mare is released from premises. This payment is good for one season's booking to said stallion. Said mare will not be released from premises until all bills (all services, boarding fee, veterinary fees, etc.) are paid. Boarding fee for mare is \$5.00 per day or \$7.00 per day with foal at side.

West Cove Quarter Horses has mare owners' permission to check said mare for normal breeding soundness and to render any treatment or immunization that may be necessary. The expense of this service will be charged to the mare owner's account.

Stallion owner or agent shall assume no liability for mare that will not breed, cannot conceive, or for accident, sickness or death of the mare and/or foal, but will exercise every reasonable effort to settle mare and use good judgment in care and supervision of mare. Mare owner shall not be responsible for injury or accident to stallion.

A PHOTOCOPY OF SAID MARE'S CERTIFICATE OF REGISTRATION MUST BE RETURNED WITH THIS CONTRACT.

West Cove Quarter Horses guarantees a live foal. A live foal is defined as one that stands and nurses after foaling. This guarantee will apply only if West Cove Quarter Horses is notified within 48 hours of death. A statement from a licensed veterinarian must follow within two weeks.

If mare proves not to be in foal in the year bred or loses her foal as stated above or if the mare should die or become unfit to breed, West Cove Quarter Horses has the following options:

- A. Re-breed the same mare THE FOLLOWING YEAR if the mare is vet-checked for sound breeding.
- B. Request a substitute mare and breed her THE FOLLOWING YEAR or
- C. Refund any service fees paid less the non-refundable booking fee.

It is further agreed that if the above said stallion dies or becomes unfit for service, West Cove Quarter Horses shall refund the service fee less the booking fee.
